### **4. REGISTRATION REPORT (Dave Mark)**

See attached Registration Report. Registration numbers were down slightly from our 610 to 620 past participants to 543 participants. With the pandemic occurring it is great to see this many players returning to play. We have about 62 teams comprised of about 8 skaters and 1 goalie.

As an organization we decided to hold registration fees to \$600 this season for all members to receive about 2 ice times per week. Current Red Zone Restrictions has limited ice times to about once per week.

Recognition goes out to Wilmot Township who have agreed to minor hockey sports to provide a cost reduction while Waterloo Region is in the Red Zone Restriction so we as an organization can provide towards the end of the season we can look at extending the season to provide value back based on how long we have Red Zone Restrictions.

This season continues to change and we appreciate everyone's patience as the schedule continues to evolve.

### **6. Financial Report (Mark Calder)**

See attached the budget presented. It has been revised about 10 times during this pandemic as it has been difficult to understand where we are at and where we are going with the ever changing landscape of hockey this season.

Registration is about \$325,000 in revenue with no representative fees this season. Sponsorship is estimated at about \$13,500 in revenue.

Clinic costs estimated at about \$10,000 increasing over years with extra clinics being done due to pandemic. Ice rental costs are expected to be about \$255,000 for the season. OMHA Insurance cost of \$34,000 along with Referees and Timekeepers among other expenses providing about a \$22,000 deficit.

Our fiscal yearend we had about \$164,000. To date we have about \$348,000 in our operating account with \$80,000 in our savings account. Financially we are able to take on a deficit this year to keep the registration costs at \$600.

See attached our annual financial audit. Sandra Forde has volunteered to be the auditor and has done this for the last fiscal period. Report results summarize all finances to appear to be in good and proper order.

Other than the Try County League AGM there has been no league communications this season. Southern Counties and Grand River Leagues have no season communications. Discussions with Waterloo Region OMHA centres (Ayr, Hespeler, Twin Centre, and Woolwich) have been ongoing to look at scheduling exhibition games awaiting relaxation from the pandemic restrictions to ensure OMHA and Waterloo Regional Health Unit protocols are followed.

NHHA has finally filled its volunteer role for organizational Head Trainer. Thank you to Sarah Francom for volunteering.

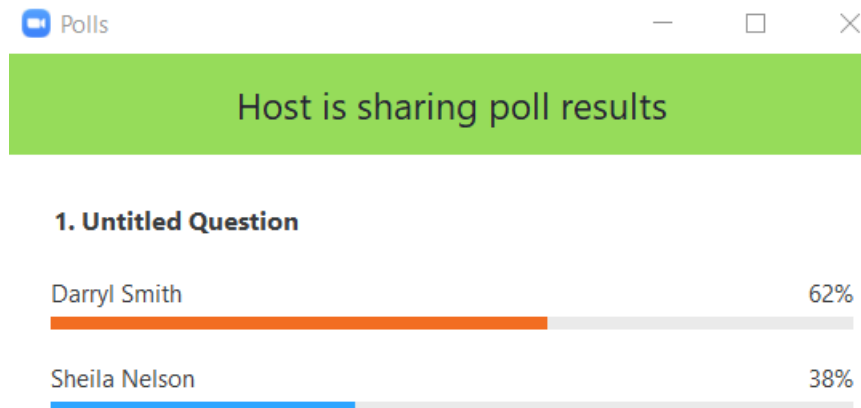

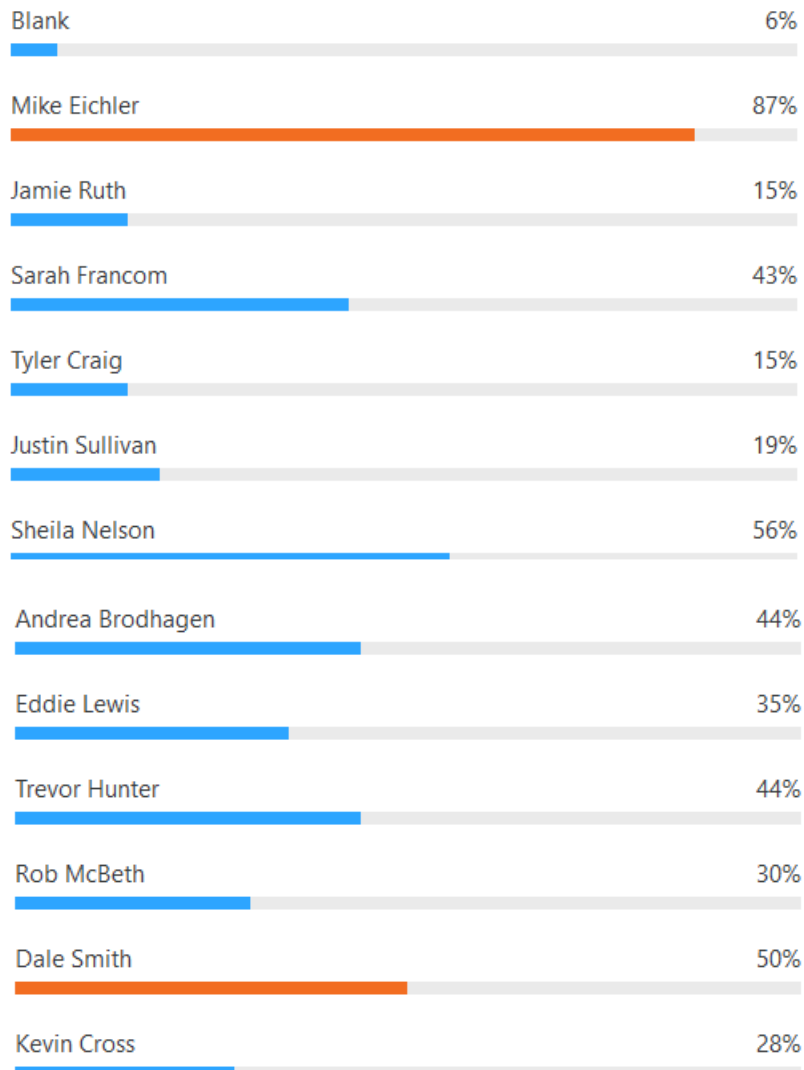

Dear Mr. Dave Mark,

I have examined the financial records for the fiscal year ending March 31, 2020 for the New Hamburg Hockey Association (The Association). I did not audit or review the information, I merely carried out a cursory examination of the financial transactions throughout the year. Please note, I have "Read Only" access to the CIBC bank account for The Association.

On a quarterly basis, I provided the Treasurer, Mark Calder, a random sampling of the expenditures for which I required the backup documentation. I also asked for documentation for all expenditures over \$7,050. On a timely basis, Mark provided me with all of the documentation that I requested. I also traced these samples to the appropriate line items on the Income and Expense Statement.

For the revenue, at the end of the year, Mark provided me with the Income and Expense Statement. Using those revenue figures, I was able to rebuild the expected registration revenue and rep fees based on numbers I was provided from the Registration system.

In my opinion, the financial records for the year April 1, 2019 to March 31, 2020 appear to be in good and proper order. Mark keeps all documentation and appears to have a solid understanding of the finances for The Association. I would like to commend him on a job well done.

### NOTICE OF PROPOSED CHANGE TO THE CONSTITUTION

In accordance with Section 25.0 'Amending the Constitution' be it hereby known that the New Hamburg Hockey Association Executive, at their meeting on March 6, 2013 resolved to recommend to the membership that the following changes be considered at the 2013 AGM:

1. Item 1.0 - Coaching Interviews

Currently defined as "Meeting to select perspective coaches." Better fit described as "Meeting to interview perspective coaches."

2. Item 1.0 - Rules of Governance

Reference is made to Robert's Rules of Order "See Article 20." Article 20 is Confidentiality. Should read "See Article 10.05."

3. Item 1.0 - Game Admissions

The section references Executive Pass Cards and Lifetime Pass Cards but is silent wrt Coach Pass Cards. Should add section "Coach Pass Card means a non-transferable pass card provided each season to the officials of each team allowing free admission to NHHA home games."

4. Item 2.4 – Affiliations

Reference is made to determination of AAA zone affiliation as being determined by the OMHA Manual of Operations. Since AAA zones are not currently described in the OMHA Manual of Operations, reference to the Manual of Operations should be deleted.

5. Item 3.7.1 – Membership Termination

OMHA and NHHA should be switched in order to reflect the progression from the local to national association.

6. Item 4.0.1 – Membership Fees

The description of "by resolution of the Executive and also by direction of the Membership" is ambiguous. The "and also" should be replaced by "or" to reflect that the fees can be independently set by either method."

7. Item 9.0.2 – Voting Procedures

Reference to Article 24 should be to Article 25.

8. Item 9.0.8 – Voting Procedures

The string "vote for the both" should read "vote for both" (i.e. delete "the").

9. Item 11.0 – Executive Board of Directors

Reference to "between 12 and 15 directors" is not consistent with Item 11.2 which describes "between six and eight" one year and two year directors. The following changes are required to reflect status quo:

- a) reference in Item 11.0 to "between 12 and 15" should be revised to "between 12 and 14" which will allow for attrition over the season;
- b) reference in Item 11.2.1 to "twenty (20)" should read "between 17 and 19";
- c) reference in Items 11.2.1.1 and 11.2.1.3 to "between six and eight" should read "seven";  
and
- d) reference in 13.2.1 to "between 12 and 15" should read "14".

10. Item 11.1 .6 - Eligibility

Reference to "members" should read "positions".

11. Item 12.2.6 – Election Procedures-AGM

Since "acclamation" means 'no opposition' reference to "acclamation" is odd. This should be reworded as "If a tie remains following a second tie vote of the same candidates, the electioneer will request the Secretary to select the winning candidate from a blind draw."

12. Item 12.4 - Absenteeism

Reference to "minimum of 50% of Executive meetings" does not provide a time frame and is therefore not measurable. Revise this to reflect 50% of current year.

13. Item 14.1.7 – The President

Reference to "and OMHA" should read "OMHA, and NHHA" to reflect progression from the national to local organizations.

14. Item 19.2.5- Proper Action

Reword to confirm that the Executive Member who declares having a child playing at that level may participate in the discussion.

15. Item 20.0.1 – Confidentiality

Reference to "Director and Officer" should read "Officer and Director" to reflect the natural order.
