### 4. Report Presentations

#### a. Registration Report (Nathan Joseph)

See attached Registration Report. Registration numbers were down to about 543 from our usual 600+ from past participants. About 57 players chose not to return due to the pandemic with 10 players returning to play AAA/NRP. We had about 31 teams with no Juvenile team this past season.

As an organization we decided to hold off on opening registration from our normal April time frame due to the pandemic and spring tryouts being cancelled. We hope to open registration for June closing in July. Registration fees for next season will be kept the same as the 2018-2019 season as per the below chart with the plan that hockey will return to normal post pandemic.

**b. Ice Scheduling Report (Nathan Joseph)**

This past season due to the pandemic was a challenge for ice scheduling. There were weekly changes with Provincial and Township updates. Restrictions to ice times required a 10-minute gap between sessions to allow players to exit and enter. NHHA was able to secure two 50-minute ice times for each team with the support of the township in operating both ice pads.

Coaches adapted very well to weekly schedule updates & big thanks to staff and parents for cooperation. Additionally, the township supported NHHA with a reduced ice cost during the red restriction zone allowing NHHA to provide credits or refunds to participants. NHHA is working with the township on ice planning to return to normal for this September with the standard 1.9% price increase that is added each year.

For next season the plan will be to start in September with preparation development skates for all ages in early September and tryouts for 'A' beginning September 24.

Coaches will need to have the required credentials and be fully certified and ready to go for the season come September. So parents be ready, be excited and have hockey gear sized up and ready to go as we look forward to have a full season next year with games, tournaments, and playoffs at all levels. Looking forward to hockey returning to normal post pandemic.

**c. Financial Report (Mark Calder)**

See attached the budget presented. Budget for next season based on full season starting in September, post pandemic plan. Note revenues are budgeted lower at \$351,000 due to extra funds allocated from the previous season carrying over. Budgeted expenses total \$471,390 with an expected loss of \$120,390. As of May 1<sup>st</sup> fiscal year we have \$134,650 in our bank account and \$80,000 in our mutual fund. This provides a slight surplus for unexpected expenses and jersey replacements.

See attached our annual financial audit. Sandra Forde has volunteered to be the auditor and has done this for the last fiscal period. Report results summarize all finances to appear to be in good and proper order.

**d. League Report (Alex Davidson)**

Linda Ralf our OMHA Regional Director has changed roles to the OMHA Treasurer. A new regional director will be assigned to our region for next season.

OMHA post-pandemic plan for next season to start in September with preparation skates first then switching to tryouts. AAA starts September 10<sup>th</sup>, AA September 17<sup>th</sup>, A September 24<sup>th</sup>. Tournaments start after October 9<sup>th</sup>. Leagues will run October until March 1<sup>st</sup> with OMHA tournament style playdowns and league playoffs in March until April. See attached Tri-County League dates for next season.

New this season is the U11 (Atom) Pathway slower start much like U8/U9 (Novice). Also new for OMHA playdowns will have 4 Tri-County teams and teams from other leagues. OMHA will continue the new U5 to U21 age category nomenclature (see attached chart). AE teams for next season will change their classification to BB, B, CC, C. These teams will still be representative hockey to even out skill level of teams from various centre sizes. The U8 Select team will now be known as MD or similar as the Select term will be reserved for House League Select teams.

At the end of December leagues will evaluate team standings (mid season point) to determine if teams are in the right spot and playing in the right division. Stronger teams might move up a division and weaker teams might move down. This is OMHA's goal to improve competition and balancing. The NHHA U12 A team has requested to play in the AA Bowen division and the drop-dead date to finalize this will be July 13<sup>th</sup>.

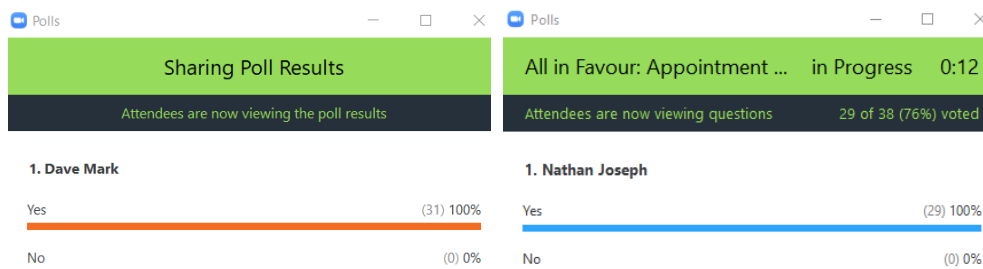

I have examined the financial records for the thirteen month fiscal year ending April 30, 2021 for the New Hamburg Hockey Association (The Association). I did not audit or review the information, I merely carried out a cursory examination of the financial transactions throughout the year. Please note, I have "Read Only" access to the CIBC bank account for The Association.

I provided the Treasurer, Mark Calder, a random sampling of the expenditures for which I required the backup documentation. I also asked for documentation for all expenditures over \$6,375. On a timely basis, Mark provided me with all of the documentation that I requested. I also traced these samples to the appropriate line items on the Income and Expense Statement.

For the revenue, at the end of the year, Mark provided me with the Income and Expense Statement. Using those revenue figures, I was able to rebuild the expected registration revenue and rep fees based on numbers I was provided from the Registration system.
