**APPENDIX 1 – REVIEW ENGAGEMENT AND APPOINTMENT OF REVIEWER**

Whereas it is good practice for New Hamburg Hockey Association (NHHA) to have an annual third-party review of the financials of the organization.

And whereas the Ontario Not-for-profit Corporations Act (ONCA) prescribes that the review be in the form of an audit if annual revenues are greater than \$500,000 unless approved by at least 80% of the members present at a general meeting (extraordinary resolution) that the review be in the form of a review engagement (less extensive and expensive than an audit).

And whereas if annual revenues are less than \$500,000 ONCA allows for both the audit and review engagement to be waived by approval of 80% of the members present at a general meeting.

And whereas Shawn Meyering of Pollard Gagliardi Navickas LLP Chartered Professional Accountants satisfactorily carried out the engagement review for the 2024-2025 fiscal year.

Be it hereby resolved that no matter the annual revenues of the New Hamburg Hockey Association the financial review for the upcoming fiscal year ending March 31, 2026 be in the form of a review engagement.

And that the review engagement be completed by Shawn Meyering of Pollard Gagliardi Navickas LLP Chartered Professional Accountants.

**APPENDIX 2 – REVISE “ANNUAL GENERAL MEETING” TO “ANNUAL MEETING”**

Whereas the NHHA Constitution has a legacy term "Annual General Meeting".

And whereas the OMHA has directed that all Centres change reference to "Annual General Meeting" to read "Annual Meeting" to be consistent with the Ontario Not-for-profit Corporations Act.

Be it hereby resolved that all future reference in NHHA documentation to "Annual General Meeting" be changed to "Annual Meeting" and that future reference to "AGM" be changed to "AM".

**APPENDIX 3 – VICE TREASURER AS NON-VOTING MEMBER**

Whereas the primary role of the Vice Treasurer is to assist the Treasurer with their duties, thus attendance at all meetings is not required to proficiently carry out their duties.

Be it hereby resolved that the NHHA Constitution be revised by adding Item "14.4.5 The Vice Treasurer is excused from attending meetings when the Treasurer is present. If the Vice Treasurer is in attendance with the Treasurer, the Vice Treasurer shall have voice but no vote. When the Treasurer is absent, the Vice Treasurer shall have both voice and vote."

## **APPENDIX 4 – APPOINTMENT OF VICE TREASURER**

**Whereas Item 11.3.1.4 of the NHHA Constitution describes " In odd numbered years, the Vice Treasurer is appointed by the Executive and ratified by the membership for a period of two years."**

**And whereas Sandra Forde has performed exemplary service to this position since the position was created in 2022.**

**And Whereas Sandra Forde has informed that if appointed she will accept the position.**

**Be it hereby resolved that the NHHA Executive appoint Sandra Forde as Vice-Treasure for the 2-year term commencing June 1, 2025.**

**And that this resolution be presented to the NHHA 2025 Annual Meeting for ratification by the membership.**

## **APPENDIX 5 – APPOINTMENT OF ELECTIONEER AND SCRUTINEER**

**Whereas Item 12.2.2 of the NHHA Constitution describes " The executive shall appoint the electioneer and scrutineer(s) for election of the officers and directors by a majority vote.**

**And whereas Matt Wilhelm has agreed to be Electioneer and Greg Roth and Tony Titus have agreed to be Scrutineers if appointed.**

**Be it hereby resolved that Matt Wilhelm be appointed as Electioneer, and Greg Roth and Tony Titus be appointed as Scrutineers for the election of Officers and Directors at the NHHA 2025 Annual Meeting.**
